I. TO CHANGE SCOPE OF WORK:

1. Removes Skyway content from Terminal C Package (Refer to drawing sheets: 1/A2.02C, AG3.000, E9.01, 1-17, 1-20, 2-36, 2-45, 2-51, 2-53, 2-54, 4-15 4-16, 4-17, 4-53, 4-54, 4-55);
2. Removes restroom area at old Terminal C North as this area is no longer in scope (Refer to drawing sheets: 1/A2.02C, 1/AD2.02C.1, AD2.02C.2, 4-43, 4-45);
3. Replaces all references to Ticketing / Check-in with Check-in (Refer to drawing sheets: 2-61, 4-7, 4-8, 4-9, 4-12, 4-16, 4-17, 4-19, 4-20, 4-63, 4-66);
4. Removes paint from Terminal Elevator cores (Refer to drawing sheets: 1-19, 2-47, 2-48, 2-49, 2-50, 4-5, 4-14, 4-23, 4-57, 4-58);
5. Adds Sign Type 1t-ID.37a; 1t-ID.37b (Restroom Super graphics) to all public restrooms (Refer to drawing sheets: 2-43, 4-24, 4-25, 4-36, 4-37, 4-38, 4-42); and
6. Adds restroom references at landside ticketing level towards baggage level (Signs TC.L2-025t and TC.L2-026t) (Refer to drawing sheet: 4-22)

When issued, Addendum shall automatically become part of the solicitation documents and shall supersede any previous specification(s) and/or provision(s) in conflict with this Addendum.
