REFERENCE: Request For Proposals for Oculus Content Management System (CMS) For Houston Airport System (HAS); Solicitation No.: H37- OCUCMS-2023-014

To: All Prospective Respondents:

This Letter of Clarification (LOC) is issued for the following reasons:

- I. **To Add Specifications documents to the solicitation for Division 27: Multimedia AV Specialty Systems.**
- II. **To Respond to questions submitted by prospective Respondents.**

1. **Question:** Has a content company and or LED manufacturer been chosen at this point? If so, are there updated final resolutions to assist in specifying CMS equipment?

Response: Both solicitations currently remain under review. A firm has not been chosen at this point. Final resolutions to assist in specifying CMS equipment are anticipated to be selected in the next 30 to 60 days.

2. **Question:** What is the probability of audio being added to this system?
