- 3rd Party Safety Brief (performed on each day of the tour), approximately 15 Minutes, prior to site visit departure.
- HRA/JSA (performed after Safety Brief), will need to be signed by all participants on the tour, approximately 10 minutes provided by Alstom.
- Any participant accessing the guideway (Maintenance Yard included) must provide a certificate of completion for the OSHA1910.30 Walking-Working Surfaces and Personal Protective Equipment (Fall Protection Systems) training before the site visit. Certificates should be submitted with this reservation form via email.
- Fall Protection equipment is required to access the Guideway. You may carry your harness and lanyard or put them in a backpack and carry them with you, it is not necessary to wear the harness during the tour.
- Per Alstom requirements, **No Electronic Devices (including cameras)** are permitted in PPE require areas, this includes the Maintenance Bay Areas, Maintenance Yard, and any portion of the Guideway.

Also, any tour participant must have their own PPE equipment:

- Fall Protection Body Harness with attaching lanyard that meets OSHA 1910.140

- (No body belts)
- Harnesses must have proof of current inspection (typically attached to the harness or provided the time of purchase)
- Safety glasses
- Safety toe shoes
- Hard hat/bump cap
- High visibility vest
- Mask that covers nose and mouth must always be worn (Optional)
