This Letter of Clarification is being issued for the following reasons:

- I. <u>EXTEND</u> the proposal due date from June 18, 2020, 10:00 A.M., to June 25, 2020, 10:00 A.M., CST.
- II. Delete Item No. 15 in its entirety Part IV Submission Proposal, Section B Submission Requirements, page 22 of 55.
- III. Respond to Questions
- 1. **Question:** Can the City provide more details in regard to the manufacturers for the electronic safety and security needed?

**Response:** The City is unable to provide specifications or details as to electronic safety and security requirements. The electronic safety and security requirements will be determined by the selected proposer.

2. **Question:** Can the City explain why the CRDC services for IAH and HOU will be located off-airport? Our company were hoping to discuss the possibility of building this CRDC to suit on-airport, which we understand is much more functional from a user's perspective.

**Response:** An on-airport site(s) has not been designated. In addition, off-airport site(s) place the proposal on a same competitive level basis of proposal and evaluation.

3. **Question:** What are the security protocols for the CRDC's at IAH and HOU? What level of products screening will be mandated, and is six-sided inspection and/or x-ray screening of goods required?

**Response:** To be determined. At a minimum, all Airport Security Operating Instructions including those established by Customs and TSA must be followed.

4. Question: Are CRDC services for all tenants or only those delivery types listed in Part II, Section 9.5?

**Response:** No. Section 9.5.5 allows for service expansion.

5. **Question:** Regarding Part II, Section 2.2.1.1, this section references removal of trash as part of the goal. What is the RFP's definition of trash? The removal of trash is not mentioned anywhere else in the RFP, only the handling of recyclable materials.

**Response:** At present, general trash removal is not in the scope. This RFP solicits only recycling and grease & cooking oil removal on an optional basis.

6. **Question:** Regarding Part III, Section 3.1.1, the sales history provided for HOU is only for food and beverages stores, please provide sales information for retail stores at HOU as well?

**Question:** If parcels are one of the delivery types, are inbound and/or outbound deliveries part of the scope of work for all tenants? If parcel deliveries are part of the scope of work, are contractors delivering to all concessionaires and/or all tenants? If the pickup of outbound parcels is part of the scope of work, does the pickup have to occur throughout the airport at all offices or will there be a central pickup location in each terminal? Will there be a cut-off time?

<u>Response</u>: If by parcels, you are referring to UPS or FedEx or other delivery services, then parcel delivery is not included in the Scope.

In our experience, CRDC operations are much more efficient and reliable when located on-airport with direct airside access.
