Question: If the answer to the above question is that we need a Senior Construction Scheduler, can 2. one person on the construction team be responsible for multiple items, for example can the project manager act as the scheduler as well?

3. **Question:** "Quality Control Manager" is noted in Attachment A for the preconstruction and closeout conference, but is not listed in "Section 11.7.4.1 Key Personnel". Please confirm that the only project roles our team needs to fulfill are those listed in "Section 11.7.4.1 Key Personnel".

Question: If the answer to the above question is that we need a Quality Control Manager, can one 4. person on the construction team be responsible for multiple items, for example can the project manager act as the QA/QC manager as well?
