Procurement Process Reminder Quiet Period



- The Quiet Period begins when the solicitation is advertised and extends until an award recommendation appears on a City Council Agenda or a City Council Committee Meeting Agenda.
- Actual and prospective bidders (including their representatives or persons acting on their behalf) are prohibited from contacting members of the City Council or any City employees other than the contracting officer.
- Actual and prospective bidders (including their representatives or persons acting on their behalf) are expressly prohibited from offering, presenting, or promising gratuities, favors, or anything of value to any member of an evaluation committee or any appointed or elected official or employee of the City of Houston, their families or staff members.
- As part of the solicitation, bidders shall attest that they understand and agree not to contact any members of City Council or City employees – other than the solicitation contact person – during the Quiet Period.
- Only the designated procurement specialist, Ola Alhammami, should be contacted during this time.

STANDIFER STREET AND LEE ROAD SINKHOLE REPAIR AND ENTRANCE REPAVING AT GEORGE BUSH INTERNATIONAL AIRPORT (IAH), Invitation to Bid (ITB): HAS seeks to demolish and reconstruct the existing asphalt pavement with continuous reinforced concrete pavement (CRCP). The project includes full-depth excavation, repair of a previously repaired sinkhole, replacement of approximately 180LF of reinforced concrete pavement (RCP) on Standifer Street, and repair work at the intersection of Standifer Street and Lee Road. The purpose is to address the aging asphalt pavement and ensure the site remains fully operational.

Project Objectives

- Excavate unsuitable material from a sinkhole at the intersection of Lee Road and Standifer Street, backfill with select material;
- Install a new 24" stormwater line; and
- Roadway alignment, channelization, pavement, traffic flow, and safety improvements of the Standifer Street entrance at Lee Road.

Delivery Method

Key Points to consider:

- Work will be constructed in two (2) phases to allow continuous access to Standifer Street as detailed in the plan set.
- Construction phasing to permit two-way traffic on Standifer Street and Lee Road.
- No stop signs nor a traffic signal will be installed at this intersection









Key Points to consider (cont.):

 The existing 24" RCP storm sewer pipe is to be removed and replaced, including the installation of precast safety end treatment headwalls at each pipe end.
