I. EXTEND solicitation due date from Thursday December 9, 2021 to Thursday December 16, 2021 at 10:30 A.M., local time.

- II. REVISE responses to questions provided in Addendum No. 4 issued November 29, 2021:
- 1. **Question #7:** Along with providing local notifications, which security alarm and notifications systems currently installed at the airport(s) will the new Exit Lane Breach Control be required to integrate with?

Response: Integration from the ELBC system to the Airport's Access Control System (ACS) and Video Management/Video Surveillance systems (VMS/VSS) is required similar to existing ELBCS at Terminal B and as shown on TY404 (IAH-C) and TY300 (HOU), as well as called out for in the Division 28 security specifications.

2. Question #23: On sheet TY000 it states that the motion detection camera, watcher camera, remote command terminal, general control rack, and auto door operator are by others. Please confirm. Is a supplier/installer selected yet?

Response: All security equipment, exit lane equipment, and integrations shown on drawings shall be provided as part of the project. No work is by others.
