1. Question: Fabrication Notes (General Design Intent)" section "F1" on drawing sheets 2-1 thru 2-46 in plans IAH Terminal C Garage Signage & Wayfinding - Volume II state to use 3M DG3 4090 film. Will you allow for use of Avery Dennison sheeting products with a digital printing process approved by TxDOT (and carrying a 15-year warranty) as an approved equal?

Response: Any substitutions must be submitted by bidder for review and approval per specification requirements and guidelines described in Documents 00210 and 01630.

2. Question: Can you confirm if bringing the power to the location of each illuminated sign should be included in our scope?

Response: Yes, if the drawings show the sign to be illuminated, then the power is in the base bid scope of work.

3. Question: Can you please advise if a signage company can bid on all signage work (Removal, Fabrication and Installation) it seems there is construction work is also required along with signage scope.

Response: A signage company can bid for this work, if the firm meets all the technical requirements of the bid documents.

4. Question: Are prequalified vendors only eligible to submit the bid on this project since all listed pregualified vendors seem construction companies?
