REFERENCE: Invitation To Bid (ITB) for the IAH Integrated Coordination Center at George

To: All Prospective Bidders:

This Addendum is issued for the following reasons:

I. Extend the Bid Due Date from November 2, 2023, to November 9, 2023, at 10:30 A.M., (CST).

II. To Respond to the following Questions.

1. **Question:** What is the definition of a Certified VAR? Is this a City certification for a contractor or are you referencing a MWBE/WBE certification?

Response: VAR = Value Added Reseller. Reseller/Installer must be certified by manufacturer to install and commission equipment. It is not related to WBE/MBE certification.

2. **Question:** Is the total number of console positions being requested on page 924 of the Project Manual 18?

Response: There are a total of 24 positions.

3. **Question:** Should the consolette antennas referenced on page 924 of the Project Manual be mounted on the tower next to the shelter or the Integrated Coordination Center (ICC) building rooftop?

Response: Motorola consoles to utilize existing antennae on the tower via the network connection. If Motorola requires consolette antenna, it can be mounted on the ICC building. TSA and HPD consolettes to utilize new antenna on the ICC building.

4. **Question:** In the event question 3 is the ICC rooftop, will any needed building penetrations be provided by the Houston Airport?

Response: No penetrations at the roof will be required. Antenna mounted on South face of

building. See details on E3 A5.31. Mounting assembly to be provided by GC.

5. **Question:** Is document 00461 available for download (Hire Houston First) or will it be provided to the respective bidders?

Response: Information pertaining to Hire Houston First (HHF) can be found at the Office of Business Opportunity (OBO) website. https://www.houstontx.gov/obo/hirehoustonfirst.html.

6. **Question:** Will a partial bid be considered a Prime contractor or must a partial bidder partner with a Prime contractor? (i.e. bidding console technology only).

Response: A partial bid will not be considered. A subcontractor should partner with a Prime contractor.

7. **Question:** Please clarify on page 924, section E of the Project Manual what an "option voice logging recorder" means. Is that an optional price for a voice logging recorder on the AIS or in addition to the AIS? Or does the airport want a price for a voice logging recorder through the AIS which records radio traffic and consolette traffic?

Response: It is to be included.

8. **Question:** Please clarify on page 924, section H that "...a new logging recorder shall be included...". Is this logging recorder for the AIS or an additional logging recorder for outside the AIS?

Response: Please provide what is required to record radio and consolette traffic.

9. Question: Can you advise if alternatives to Evans Next Gen consoles can be submitted for this project? Adaptaspace designs and manufactures consoles for Command & control area as well as EOC's and we compete well in terms of features and benefits in comparison to Evans. I have attached a layout of a project that we are currently working on that has a similar layout compared to those in the drawings. We can scale to meet your size requirements. The product is height adjustable, and has monitor mounted to our Flex Rail System. We have a Monitor Array that can also be used.

Response: Yes. Alternates are acceptable when they match all functional aspects of the Basis of Design (EVANS consoles). Contractor is expected to comply with HAS Division 01 Substitutions

Primary Base of Design dimensions shown in Contract documents. Essential will be:

- 1. a dimensional (footprint) match.
- 2. monitor configuration match.
- 10. **Question:** I am not sure if the GC is responsible for the new consoles or if the airport/city will be procuring in separate solicitation?

Response: GC is responsible for purchase and installation of the control consoles furniture system (24-Total).
