To: All Prospective Bidders:

This Addendum is being issued for the following reason:

- I. Respond to questions.
- 1. **Question:** Could we offer a second option with notes on the differences? We are proposing to offer it up front so the city has all needed info to make bids, wed offer a normal bid per specs, an alternate with the changes made, and that's it, would doing that disqualify our bids?

**Response:** The bid needs to be to the scope/specifications advertised. Only one bid meeting the specifications/scope will be accepted. Any substitutions can be recommended if awarded the contract.

2. **Question:** Just to clarify, when it says, "Existing surface-mounted signs to be removed/patch repair as required," does this mean the sign stays in place, gets cleaned and serviced, and is reinstalled, or is it a full removal?

**Response:** No full removal is not required. It would depend on the condition of the sign how much renewal is needed, but complete replacement is not being requested in the comment.

When issued, Addendum shall automatically become part of the solicitation documents and shall supersede any previous specification(s) and/or provision(s) in conflict with this Addendum. Addenda will be incorporated into the Contract as applicable. It is the responsibility of the bidder(s) to ensure that it has obtained all such Addenda. By submitting a bid on this project, bidder(s) shall be deemed to have received all Addenda.
