This Addendum is being issued for the following reason:

II. Response to Question:

Question: The plans do not specifically call for flaggers at the active taxiway (ADG III) where the haul road crosses, will this be a requirement? If so it should be shown on the plans. The phasing plans show the use of low-level barricades for closing Taxiways, but there isn't anything showing flagging at the active taxiway crossing.

Response: The haul road does not cross any active taxiways. The first phase of construction revises the striping to move the movement area boundary away from the construction site. The haul road will cross a taxilane on the North Apron, which has flaggers shown currently in the plans.
