### Pay or Play (POP) Forms

On July 1, 2007, the Pay or Play (POP) program was implemented by the Mayor, through Executive Order 1-7, in an effort to promote a work environment that supports a quality workforce for employees working on City contracts, and to enhance fairness in the City's bidding process for contracts.

It is the policy of the City of Houston to require certain contractors to either; contribute a designated amount to be used to offset the costs of providing healthcare to uninsured people in the Houston/Harris County area (PAY), or to require certain contractors to provide to certain employees a minimum level of healthcare benefits (PLAY). The Office of Business Opportunity serves as the Administrator of the POP program. Please view the POP Presentation and Pay or Play Program Requirements for more details about the program.

Fuel Tank Relocation By Others



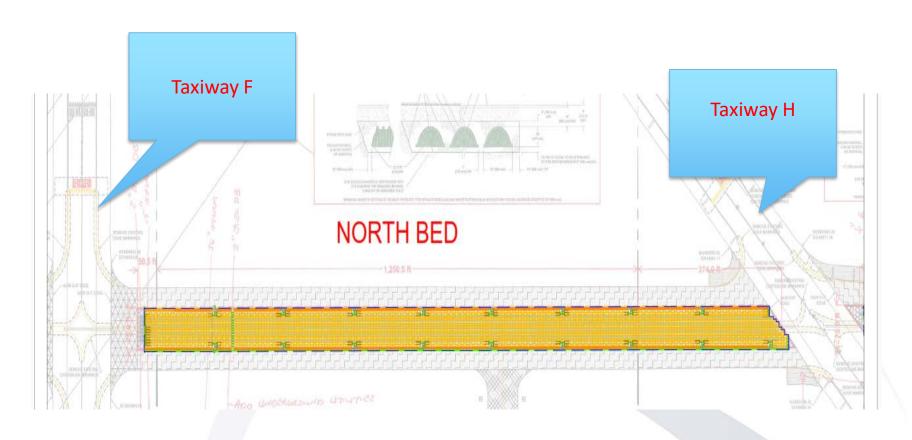


### Scope:

- 770 B Includes:
  - Pavement Removal and Disposal
  - Fill, graded to match existing storm flow pattern(s)
  - Revised Signage, Lighting, and Markings.
  - Alternate Bid Item (excluded from evaluation of Bid)

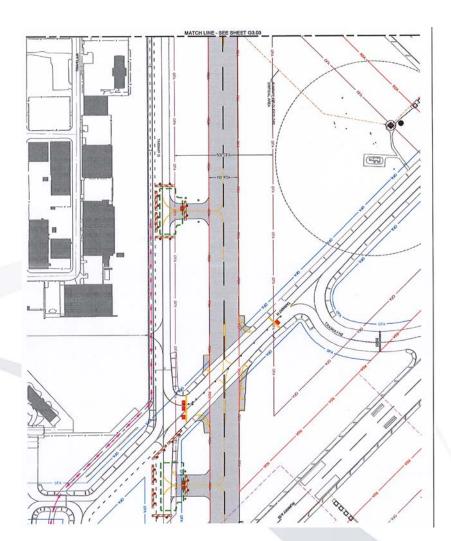


### **Scope (Continued):**





- Proposed Phased Demolition
- Intersections with FBOs
- Functioning Airport
- Aged Pavement to Demolish
- Accessways/Haul Routes





- No seeding on airfield (temp or perm)
- Laydown Area, environmental benchmarking, HAS access
- Cash Allowances for safety, utilities, permits, etc. (T&M)
- Traffic Control: Bid item all inclusive
- Flaggers: bid item all inclusive
- Pavement Thicknesses vary, plan quantity approach
- Alternate not part of the base bid
- Alternate may, or may not, be chosen
- Alternate Provider MUST be FAA certified, product must be proven airfield worthy for the Fleet Mix at HOU



- Contract language has been updated based on LLs
- Bid tab references Specifications, please read
- Contractor is responsible for sub performance (evaluations)
- \$10mm Airfield Insurance
- Hourly price for weather hold backs
- Daily price for General Conditions



- All submittals to be approved prior to any construction
- Retainage held until Substantial Completion, and acceptable to owner, sub's retainage will be paid.
- Longer payment cycles, especially @ beginning
- Working at Active Airport Restrictions
- Meeting FAA Requirements, exactly, no Mod to Stds.
- Change Orders will be rare.
- Bid Fully and Responsibly

  - SRA completed, 7460s submitted
  - Environmental Assessment: In Final FAA Review
  - Construction NTP November 2020 (caution: black out dates)
  - Interim HAS: Signage/Marking Removals, Electrical, other
